IMPORTANT NOTICE - RESTRICTED BREED DOG

The State Government has recently made significant amendments to the Domestic Animals Act 1994 in relation to the keeping of "RESTRICTED BREED DOGS". A "RESTRICTED BREED DOG" means a dog of a breed whose importation into Australia is prohibited under the Customs (Prohibited Imports) Regulations 1956 of the Commonwealth.

These breeds currently are:

Dogo Argentino
Fila Brasileiro

Japanese Tosa American
Pit Bull Terrier

Pit Bull Terrier
Perro de Presa Canario

The Act requires that if you are the owner of a "RESTRICTED BREED DOG" as identified above, you must notify Council by making a declaration (See Below). On receipt of the declaration Council will then formally advise you of the current requirements of the legislation in the keeping of "RESTRICTED BREED DOGS". FAILURE TO COMPLY WITH THE LEGISLATION REQUIREMENTS MAY RESULT IN A \$1652 PENALTY BEING INCURRED.
